Office Order

Vide memo No. 2560 dated 07.08.2018, Department of Animal and Fish Resources (GoB) has issued instruction towards implementation of free distribution of 3 breedable goats among 3849 desiring goat rearers/poor households of different categories within state for the year 2018-19.

Its implementation has to be carried out by JEEVIKA. It has been decided that this intervention would be taken up in 9 districts and this target would be distributed as below:

Above-mentioned districts should ensure formation of new 98 Goat PGs as per PG policy circulated earlier vide BRLPS/Project/463/13/1042, dated 31-05-17 and open Bank Accounts of PGs within one month.

Manager-Livestock/YP-Livestock should ensure Module-1 training to newly formed Goat PGs before goat distribution.

It is directed that implementation of Goat distribution to 4003 HHs as circulated vide BRLPS/Project/463/13/592 dated 24.05.2018 as well as to 3849 HHs as mentioned above has to be done through approved DBT guideline circulated vide BRLPS/Project/463/13/Vol:2/4764 dated 05.03.2018.

It is also expected that targets as distributed above would be achieved along with mandatory MIS updation by November 2018.

Adherence to norms should also be ensured.
