Expression of interest is invited from chartered accountant firms for appointment of **Financial Management and Technical Support Consultant** for Bihar Rural Livelihoods Promotion Society for the year 2009-10 and further extendable up to additional two years on a yearly renewal basis based on performance and requirement of project.

1. The Government of Bihar has received a credit from the international development association/world bank for financing BRLPS and intends to apply a part of the proceeds towards payment under the contract for assignment.
2. The selection of FMTSC will be as per procurement guidelines of the World Bank.
3. The eligibility criteria for selection are as follows.
 - a) Firm must be empanelled with comptroller and Auditor General of India.
 - b) Firm must have an average Annual turnover of Rs. 10.00 Lac in the last three years.
 - c) Firm must be a partnership firm.
 - d) Firm must have minimum 3 years experience of financial accounting, management and procurement related consultancy in externally aided projects in the rural / social sector preferably in the World Bank projects.
 - e) Firm having experience in the project handling SHG/Micro finance will be preferred.
4. Information regarding fulfillment of eligibility criteria should be provided in tabular form together with the preference, evidence. Number, name and year of the World Bank project / externally aided project / relevant experience separately.
5. Short listed Firm will be asked to submit Technical and financial proposals.
