
Major Deliverable and Expected Output for three months period (1st Jan to 31st March, 2016) of deputation :

4	Submission of IHHL UC to District Water Sanitation Committee (DWSC) for at least 50% of total fund received in previous 3 months .	Submission of UC for 50% of total fund received in previous 3 months.

1. Above assigned task and output will be considered as their KPI.
2. During the period of deputation the managers will be stay in the block assigned. Tours will be considered for TA/DA claims as per HRD norms.
3. All deputed managers will be paid **monthly facilitation allowance of Rs.8000/-** from assigned districts against the approved absentee & below given assigned output.
 - 1st Month: Completion of WASH plan of minimum 5 VOs.
 - 2nd Month: Completion of WASH plan of minimum another 5 VOs.
 - 3rd Month: Completion of WASH plan of one cluster of assigned block.
4. DPCU will provide a separate vehicle for 6 days in a month to each manager-H&N placed in the district for field mobility. The expenditure will be booked under the DPCU vehicle expenses as additional approval.
5. Monthly salary will be paid by the parent district of the respective manager-H&N based on the absentee statement provided by the DPM of assigned district.
