## Office Order

It was reported on 01/03/2016 by the DPM Bhagalpur that a sum of more than six lakh belonging to certain VOs had been misappropriated by Mr. Karan Kumar, Area Coordinator, BPIU Kahalgaon, in collusion with Mr. Ajay Kumar Anand, the then BPM, Kahalgaon

An Inquiry Committee, constituted by the SPMU, also found both Mr. Karan Kumar, the then area Coordinator, BPIU Kahalgaon and Mr. Ajay Kumar Anand, the then BPM, Kahalgaon guilty of misappropriation of community fund to the tune of Rs.7,06,919/- and recommended their termination.

Mr. Ajay Kumar Anand had been arrested by the police, for his alleged involvement in the case on 20/08/2016 in course of investigation in respect of the FIR against Mr. Karan Kumar, the then AC, Kahalgaon, filed by Mr. Ajay Kumar Anand himself after being instructed to do so by the DPM, Bhagalpur.

A show-cause notice dated 20.08.2016 was sent to Mr. Ajay Kumar Anand, who had been in judicial custody, through officials of the DPCU, Bhagalpur. But Mr. Anand refused to receive the Show Cause notice making it clear that he had no intension of refuting charges levelled against him.

Thus, Mr. Ajay Kumar Anand has committed grave misconduct as per provisions of Sl. No. 1,6,12,13,15 & 17 of annexure 6 (b) of para 11 and by contravening guidelines as contained in Sl. No. 13.2,13.4,13.5,13.9 of para 13 of HRD Manual, has rendered himself liable for disciplinary action.

Earlier also, when he was posted as BPM, Jhanjharpur, Madhubani, Mr Ajay Kumar Anand, had been found guilty of financial irregularities and had been penalized and warned that if found indulging in such practices again in future, his contract with the BRLPS would be terminated.

Therefore, since Mr. Ajay Kumar Anand, has been found guilty of misappropriation of fund and has been under judicial custody concerning FIR

No130/16, dt 22/04/2016 and since his antecedent is also tainted, his contract with BRLPS is being terminated with effect from 20/08/2016
