Assignment Title: **Hiring an agency for conducting Baseline Survey of Bihar Transformative Development Project (BTDP)**

The Government of Bihar has applied for financing from the World Bank towards the cost of Bihar Transformative Development Project (BTDP) and intends to apply part of the proceeds for consulting services. The BTDP project will be implemented through Bihar Rural Livelihoods Promotion Society (BRLP) for a period of 6 years. It is expected to cover around 60 lakh poor families spread over 300 blocks across 32 districts of Bihar under the project.

The purpose of this assignment is to collect and document Baseline from the target families and the villages in which they live, using surveys, economic experiments, and PRA techniques. These data will serve as inputs for macro and micro level assessments of the resource base, socio-economic status, institutional arrangements, and service delivery in Project treatment villages.
